- xviii) Any other use full object with respect to which the State Legislature has power to make laws.

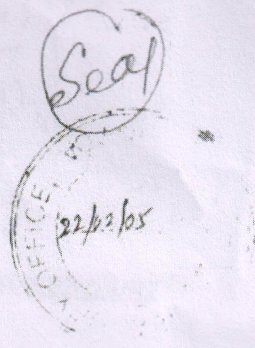
